Headquartered in Youngstown, Ohio with an office in Tampa, Florida, Redstone's portfolio is currently comprised of more than four million square feet of commercial real estate located in 15 states. Through their leadership, Lee and Jonathan expanded the Redstone portfolio to include Redstone Commercial LLC, a real estate brokerage entity that also provides asset management services for financial institutions and other third parties. And, in 2011, they established Redstone Funding, LLC, an entity which has had tremendous success buying notes from numerous financial institutions throughout the United States.

Lee serves on the Board of Directors of United Community Financial Corp. (NASDAQ: UCFC) and its subsidiary, The Home Savings and Loan Company. He is a member of the Board of Directors of Cardinal Commerce Corporation, a Cleveland-based company engaged in the authentication of electronic payments and in the enabling of secure transactions and mobile payments for both e-commerce and mobile commerce.
